The experience of RRI in Western Macedonia

The Region of Western Macedonia (RWM) in Greece has been in the process of energy transition since 2021, implementing the mega task of abandonment of its lignite-based production model and moving to a new development model, based on sustainability and innovation.

The participating citizens and the stakeholders of the RRI-LEADERS project in Western Macedonia appear to follow a similar pattern in adopting actions that encompass "responsibility" in the direction of social benefit and regional development. [Read more.](#)
